

#### Higher Registration Fees, Gas Taxes




# Just 38 percent of Idaho voters support higher use fees, including vehicle registration fees and gas taxes to pay for a transportation funding shortage

Q. Would you support or oppose higher use fees, including vehicle registration fees and gas taxes, to pay for transportation funding shortages?


#### A simple majority of Idaho voters would support higher transportation fees and taxes if all highway user groups pay their fair share

# Support of Legislative Action to Grant Local Option Tax Authority




# Slim majority supports legislative action to grant local option tax authority

# Local Option: Roads/Bridges or Public Transportation?




### **Distracted Driving**


# Support Legislative Action to Prohibit Using a Cell Phone for Any Purpose While Driving




#### 79% of Idaho voters support an enhanced penalty or fine for drivers using a cell phone or other electronic device

### No Use of Cell Phones for Drivers 17 and Under as




# Support for a law specifically banning texting while driving

# Enhanced Penalty for Moving Violation When Driver is Using a Cell Phone or Electronic Device




#### An overwhelming majority supports change in state law to ban use of cell phones during education process as condition to getting a driver's license


# 84% of Idaho voters oppose removing driver training from public schools

Riley Research Associates of Portland, OR conducted a survey of 400 Idaho voters regarding their opinions on topics of current interest. These summaries reflect responses to a telephone survey conducted from Nov. 23 to Nov. 30, 2011. The scientific telephone survey is representative of Idaho's likely voting public, qualified as those having voted in at least two of the past four major elections. A sample of 400 is accurate to within +/-5% confidence levels. The sample demographics are comparable to Idaho's likely voter population, including relative proportions for gender, age, and region. Respondents represent 41 of Idaho's 44 counties. The responses are also available based on the respondents residence in one of six Idaho transportation districts. These abbreviated graphs do not show all the detailed information collected, including the level of support or opposition.
